Why introduce measures?

Home Office forces – Fastest growing crime
Actual crime levels are unknown
Sections of the industry engaging in criminal activity
HMRC £5.6bn industry – TAX Gap
Multi Tier – Cash industry supports crime

Operation Tornado Why?

Fragmented enforcement – displacement Forces adopting different measures – confusing and ineffective Police and Industry need to work together – BMRA/Police Setting the standard nationally Home Office/ACPO driven strategy to standardise enforcement Doing nothing – not an option Set a framework and processes to support legislative change Become more efficient Reduce crime



Operation TORNADO Strategy

ACPO/BMRA/BTP/Home Office Forces

National roll out – Complete by October 2012 Support from recycling industry/Home Office More stringent controls – Identification and retention of ID Target non participating dealers Support and enhance existing force strategies and operations Stringent enforcement - Current legislation The aim is to reduce the sale and movement of stolen material

What's Required From Dealers who Participate;

Evidence of identity will be required from all persons disposing of metals for cash payment.

- UK photocard driving licence (includes address) or,
- UK passport or original passport from any nationality, or official national identity card supported by a utility bill. (not more than three months old to the current date) showing the seller's current address.
 - The yard will record each document presented by obtaining a copy which will be retained for inspection by the police and other agencies (e.g. passport, driving licence and utility bill). The photo ID will be required on each and every transaction. The ID will be copied and either physically or electronically stored with the record of transaction for a minimum period of 12 months.

Enhance existing CCTV or install a systems to record entrances, weight bridges and cash offices etc to a suitable standard



TACTICS

Multi Agency approach Identify SMD's and visit them – Develop intelligence Assess, monitor and check compliance Target non conforming dealers Planned Operations Develop relationships Identify the thieves Reduce avenues for stolen metal





What We Encountered

Benefits;

Reduces outlets willing to take metal Co-ordinates enforcement - Improves efficiency Develops multi agency strategies Raises the profile – Industry and enforcement Regional intelligence picture Develops confidence (Communities, industry, etc) Very successful – Why?



Continued

Challenges;

Identifying dealers – records don't reflect reality Drawing agencies together Changing existing practices (Industry and Police) Merging existing operations – Prevents duplication The intelligence picture – Disjointed Classification of Yards – RAG (Local force led and owned) Ensuring compliance - How?



Outcomes

85% of yards in in North East signed up Significant reductions in crime across the region; BTP -60% Durham -50% Cleveland -55% Northumbria -40% Yorkshire and Humber, East Midlands, Norfolk (West Midlands, MPS, NW SW, Eastern and Southern – going live) **BMRA** support Significant media interest – Keep the pressure up Clear signal of intention



Next Steps

National roll out - Maintaining the brand and conditions Continue to develop and improve Tornado Standardise the status of yards - Home Office forces Coordinated enforcement activity – National list of Yards Framework for cashless trading - Support future legislation Compile a national register of recyclers Embed scrap dealer activity in core policing
